WESTPEX, Inc. was organized for the express purpose of advancing the cause of Philately through exhibitions and educational programs. WESTPEX is a certified World Series of Philately (WSP) show

- 1. ELIGIBILITY WESTPEX is an open show, subject to the rules and regulations in this prospectus. Exhibits must be the *bona fide* property of the exhibitor or an immediate family member, multi-ownership will not be accepted. Any exhibit which has won a Large Gold or Gold Award at WESTPEX in the last five years must show *significant* new write-up and/or new material. An exhibit that has been purchased intact may not be exhibited for two years unless the addition of new material and text has substantially altered the exhibit.
- 2. ENTRY All exhibits must be classified on the Entry Form (over) according to one of the sections and be accompanied by the correct fees. WESTPEX reserves the right to reject any entry. Because of the demand for exhibit frames, exhibitors should not expect more than one exhibit per exhibitor to be accepted. Acknowledgment of an entry does not signify acceptance for exhibition. Signing of the Entry Form denotes acceptance of the rules and regulations in this prospectus

- 3. FRAMES Each frame will hold 16-8 1/2" x 11" or A4 size pages or 12-10" x 12" pages. Page sizes other than those listed must receive advance approval of the Exhibit Team Leader. There is a maximum of ten frames. *One-frame exhibits must be subjects related to the Convening Societies*. Youth a minimum of one frame and a maximum of five. Because frames are usually oversubscribed exhibitors are limited to one multi-frame exhibit and one one-frame exhibit.
- 4. FEES . THREE or more frame exhibits \$20 per frame . One and two frame exhibits have a flat fee of \$50. Youth is \$1 per

frame. Each exhibitor and one guest will receive free admission.

- 5. CLOSING DATE February 28, 2025, or when frames are subscribed. Exhibitors will be notified of acceptance or declination as soon as possible.
- 6. DELIVERY All exhibits must be forwarded prepaid. Directions for mail-in exhibits will be sent with acceptances. Personally delivered exhibits will be accepted at the WESTPEX Exhibit Check-In between the hours of 4 PM and 6PM, Thursday April 24.
- 7. RETURN No exhibit may be removed until released by the Exhibit Team Leader. Exhibits may not be dismounted on Sunday until all visitors have cleared the exhibit area. The dismounting will begin at 3:30 PM. Mail-in exhibits will be returned by Express Mail. Exhibitors desiring another return method must make their own arrangements. Return postage in the amount of, at least, \$40.00 must accompany the entry; any excess above \$2.00 will be refunded. Any shortfall will be billed.
- 8. JUDGING A panel of at least five A.P.S. Accredited Judges will be provided. The decisions of the judges will be final.
- 9. AWARDS After the exhibits have been judged by accepted standards of philatelic achievement, WESTPEX Large Gold, Gold, Large Vermeil, Vermeil, Large Silver, Silver, Silver-Bronze or Bronze medals will be awarded to all winners without regard to Section. Many special awards will also be available.
- 10. INSURANCE Owners must provide their own insurance. All reasonable precautions will be taken for the safety of exhibits. Uniformed guards will be on duty day and night. Owner authorizes WESTPEX, Inc., together with all their committees to act as his/her agents. Owner hereby agrees to accept all acts done by the afore mentioned parties, and the San Francisco Marriott Waterfront Hotel in conjunction therewith, and agrees to hold each and all of these free and harmless from any liability by reason of any and all such acts.
- 11. QUESTIONS Any and all questions that may arise concerning the exhibition and not provided for by these rules and regulations shall be decided by the WESTPEX Chairman of the Board at his sole and absolute discretion.

### **FIP Option program at WESTPEX**

Exhibitors interested in exhibiting on the international level may request the "FIP Option." This is in addition and independent of the regular competition and will be judged by separate FIP qualified judges. No separate awards are provided for FIP option exhibits. The FIP Option provides exhibitors with a point breakdown, written comments, and the opportunity to meet with the FIP judges at the show. The FIP jurors may decline to judge any exhibit they deem outside their collective area of expertise in which case the FIP option entry fee of \$30 will be refunded. The FIP Option is limited to the first 12 exhibits that apply. Exhibitors selecting the option should have read the appropriate GREVs and SREVs for international exhibits.
